In response to your letter, we would like to thank you for your reply in which you clarify that the Republic of Bulgaria does not intent to participate in the transboundary EIA procedure on Greek territory for the project: "Construction of a natural gas pipeline interconnector Greece-Bulgaria".

Furthermore, in relation to the intention of the Greek side to continue the participation in the Bulgarian national BIA procedure, we wish to inform you that, since no significant negative impacts in a transboundary context are expected, as concluded from the BIA documentation for the Greek side of the pipeline as well as from the additional information on the absence of significant negative transboundary impacts, deriving from the BIA documentation for the Bulgarian side of the pipeline and provided us with your letter, Greece has no further intention to participate in the above mentioned procedure.
